Firefighter of the Year: President Vella reported:

-Suffolk County Firefighter of the Year is Kevin Smith from the Deer Park FD. He will be honored at our dinner in October

Audit: No report

EMS: Meryl Montrose reported:

-Electronic PCR's, there are only 3 agencies using them, East Hampton VAC, Sag Harbor VAC and North Amityville Volunteer Fire Company. There are numerous other agencies in various stages of in-house training and equipment procurement. Two agencies voluntarily opted out and have returned to using paper PCR's

-Version 6 of the New York State PCR (paper) will be released shortly. It will contain roughly 210 data points at a MINIMUM of 4 pages. They will not be printing the version 6 PCR, a PDF will be available to all regions. The State announced that roughly 70% of PCR's submitted are from the electronic PCR platform

-Stony Brook University Hospital is pulling out of its 1st Responder agreement with 4 east end agencies as of September 2, 2011. The County is working with these departments trying to put something else in place (possibly what Islip Town did when North Shore pulled the Medics out of Southside Hospital)

-Completed installation of medical grade oxygen generator unit at Suffolk County FRES. This unit is capable of generating medical grade oxygen from ambient air and also allows for the establishment of a mobile cascade system to supply oxygen to remote locations. It was purchased with Homeland Security funds in an effort to support EMS and hospitals in conditions of increased surge

-Spoke again about narrow banding of VHF starting in 2013 and the possibility of some older radio equipment, including pagers not being compatible. Departments need to check with their individual vendors
